The South Windsor Swim and Tennis Club was founded by a group of individuals who built the Club themselves by donating their time, energy and services.

Volunteering at the Club is a tradition and all members are expected to work on committees throughout the season. The committee chairpersons will appeal for help in newsletters bulletin board postings and emails. In addition, we also have a workday in the Spring and Fall. Each member family is required to work 8 hours during the season or pay the \$250.00 work fee.

Capital Investment

The South Windsor Swim and Tennis Club requires family membership applicants become bonded members. Bonded members pay a one-time, \$1,000 bond plus 10% state tax, that holds their position in the Club. This bond can be used as credit towards your final years membership dues or be refunded per the By-Laws. Please note that if you choose to be refunded, it may take years to receive your refund per Board approval of the current year budget. The By-Laws provide for a first in/first out repayment of these funds.

Membership Level

- Try It Summer Special 2019 (\$850 membership fee, plus 10% state tax = \$935)
- Full Family Membership (\$1,175 + \$117.50 tax, plus bond \$1,000 + \$100 tax = \$2,392.50)
- Adult Individual (\$587.50 + \$58.75 tax = \$646.25, no bond, no work hours)
- Teen Swim and Tennis – 14+ under 19 (\$352.50 + \$35.25 tax = \$387.75, no bond, no work hours)
- Tennis Only (\$352.50 + \$35.25 tax = \$387.75, no bond, no work hours)

Dues are payable by all members. Our dues and bond payments are subject to the current 10% state entertainment tax.

I agree to abide by the Constitution and By-laws of the Club and all rules and regulations promulgated by the Directors and Officers thereof. I also agree to pay yearly dues for the operation and maintenance of the pool and tennis courts and applicable State taxes on all charges. I also agree to participate in the operation of the Club as defined in the By-laws or pay the designated additional fees.
